PRISM SANDBOX TERMS OF SERVICE

These PRISM Sandbox Terms of Service (the "**Agreement**") govern your access to and use of the PRISM Sandbox, including all software, documentation, web pages, forums, communication channels, tools, downloads, support and other services (together, "the **PRISM Sandbox**"). This Agreement is between you ("**you**" or "**user**") and IOG Singapore Pte. Ltd (together with our subsidiaries and affiliates, referred to as "**IOG**," "**we**," or "**use**").

BY PRESSING "I AGREE" AT THE END OF THIS AGREEMENT, AND/OR BY ACCESSING THE PRISM SANDBOX, YOU AGREE TO THESE TERMS. IF YOU DO NOT ACCEPT THIS ENTIRE AGREEMENT, OR DO NOT HAVE THE AUTHORITY TO ENTER INTO THIS AGREEMENT, DO NOT PRESS "I AGREE" AND DO NOT ACCESS THE PRISM SANDBOX. ALL USE OF THE PRISM SANDBOX IS AT YOUR OWN RISK.

General

All use of the PRISM Sandbox is governed by this Agreement and the <u>IOG Terms of Use</u> ("**IOG Terms**"), which are incorporated in their entirety into this Agreement (for the purposes of this Agreement, "**Products**" includes the PRISM Sandbox). By accepting this Agreement, you represent that you have read and agree to the IOG Terms, which cover the rules of acceptable use of IOG web sites, privacy, IP ownership, licensing, disclaimers, limitations on liability, and general legal provisions.

By agreeing to these terms and registering for a PRISM Sandbox profile, you represent and warrant that (i) all registration information you submit to IOG is truthful and accurate; (ii) you have the right, authority, and capacity to agree to and abide by this Agreement; (iii) you are 18 years or older; (iv) your use of the PRISM Sandbox will always be in strict compliance with this Agreement and all terms incorporated herein and (v) you are not subject of any sanctions administered or enforced by the U.S. Department of Treasury's Office of Foreign Assets Control (the"**OFAC**"), the United Nations Security Council (the "**UNSC**"), the European Union, Her Majesty's Treasury (the "**HMT**"), or other relevant sanctions authority (collectively, "**Sanctions**"), nor are you located, organized or resident in a country or territory that is the subject of country-wide or territory-wide Sanctions. The PRISM Sandbox offers users access to a developer sandbox intended for the development and testing of the Atala software. This service is provided to users for their convenience, without an obligation to provide technical support or assistance. IOG may reset, refresh, delay, cancel or reschedule access to the PRISM Sandbox for any reason and without notice. IOG may also terminate access and/or remove user accounts for any violation of this Agreement or other improper conduct when using the PRISM Sandbox.

The PRISM Sandbox may provide you limited access to other IOG Products, services, software, APIs, SDKs, sample code, and other technologies. This access is only for the purposes of using the PRISM Sandbox as intended and for the duration of your access, and some features and functionality may not be available. In no event shall IOG have any liability related to your use of the PRISM Sandbox, including inability to access the PRISM Sandbox and loss of your data, regardless of the reason.

Support

Privacy

IOG will collect, use and process your data in accordance with <u>IOG's Privacy Policy</u> ("**Privacy Policy**"), which is incorporated into this Agreement. By accepting this Agreement, and unless you have opted out in accordance with the IOG Privacy Policy, you agree that IOG may contact you via email or other contact information provided in your registration with information related to your use of the PRISM Sandbox. You also agree that other users can contact you and view information about your activity within the PRISM Sandbox, including what projects you have worked on in the PRISM Sandbox.

If you do not agree with the changes, you must discontinue using the PRISM Sandbox at that time. If you continue accessing the PRISM Sandbox after that time, you will be deemed to have accepted the changes to this Agreement.
